ongtime member and Local 295 Secretary-Treasurer Charlie Russo retired on February 28. Russo, 62, has been a Teamster since 1967.

"It's been an honor and a privilege to serve the members of Local 295. But it's time for me to move on and spend more time with my family," said Charlie at his retirement celebration.

Charlie's first job as a Teamster was as a fuel oil driver in Local 553, where he followed in the footsteps of his father and father-in-law. In the summer of '69, he joined Local 295 working for Mark IV

Airfreight. He has also worked for Novo Airfreight, ACI and Airborne Express.

"Charlie is everything we want our members to be," said Local 295 President Lou Calemine. "We're losing a great union man and a great friend."

Charlie served as a shop steward from 1992 to 2003, when he was elected to serve as Secretary-Treasurer. He was also a Trustee to the 295/851 Pension and Health & Welfare Trust Funds.

Welfare Fund Expands PPO Network

On February 1, the Local 295/Local 851 Welfare Fund changed from using the PPO of Horizon Healthcare to the PPO of Empire Blue Cross. This PPO network is available worldwide. It gives members a much greater choice of in-network providers and provides savings to the Welfare Fund. The switch also includes a new prescription plan. Members can now use one identification card for all hospital, medical, surgical and prescription services. The Board of Trustees and the Administrator of the Fund are always looking for ways to protect and improve members' benefits, while keeping costs to the Funds down at the same time.

295 Wins Long-Term/Short-Term **Disability Coverage for Members**

In response to requests from members, Local 295 went outside of the union's contracts and secured long-term and short-term disability coverage that is in addition to coverage provided in the contracts and by the Funds. This benefit is in all DHL contracts and will be added to other contracts.

"We used our group purchasing power to negotiate directly with the insurance company to get a discounted plan for our members," said Local 295 President Lou Calemine. "We then went to DHL and convinced the company to let members conveniently pay their premiums for the policies through check-off payroll deduction. So far, over 1,400 members have signed up."

DRIVE Time

DRIVE (Democrat Republican Independent Voter Education) is gearing up for the 2008 presidential campaign. You can't open up the paper without seeing the Democratic and Republican candidates – and the primaries don't start for months!

"DRIVE is a very important and effective program. Companies have so much money to fight us, but our unity helps balance the playing field," said 295 President Lou Calemine. "But, members also need to register to vote, vote in

elections, and make phone calls to their elected officials. We always need to be active to make our voices heard."

Teamster members showed their power in two recent victories. The first is the passage of the Employee Free Choice Act in the House of Representatives. If passed by the Senate and signed into law by the President, the act would strengthen protections for workers trying to form a union. Secondly, the Teamsters stopped a bill that would have stripped away overtime pay

rights for truck drivers who operate trucks that are 10,000 pounds or less. While 295 members are protected in their contracts, if this bill had passed, non-union competitors would have gained an unfair advantage and union companies would have tried to use it as a threat in negotiations.

n December, Local 295 and Local 851 held a shop steward seminar. 295 President Lou Calemine and 851 President Tom Conelias led the meeting, which featured: IBT Vice President-elect and Local 111 President Dan Kane, Sr.; representatives from the 295 and 851 benefit funds; Joe Robinson, 295/851 Retirees Chapter President; Local 295's attorneys; officers from Teamsters Local 202; Katie Anne O'Connor from the International Warehouse Division talking about Wal-Mart; IBT Government Affairs Rep. Joe Saroli; International Rep. George Geller; and others.

"The members of Locals 295 and 851 are part of a big team," said

Calemine. "We start with the members, the Executive Boards and the staff. We

also have Fund Administrators, lawyers, accountants, investment advisors and others who share our vision. DHL is the biggest freight transportation company in the world. Companies like DHL and UPS can afford enormous teams of unionbusting attorneys, lobbyists and even anti-union politicians dedicated to keeping workers and the costs of labor down. It's important for the members to see that they're not in this fight alone."

Calemine and Conelias made a special presentation to Mario Giovanniello, who was instrumental in organizing Building 263. He started

out as a member of Local 851 and is now in 295. Mario was awarded a Teamster jacket with the logos of both locals.

The meeting also featured a talk by Eddie Mustafa Muhammad, the leader of the Joint Association of Boxers (JAB), a Teamster affiliate fighting to bring union protections and respect to professional boxers. With Mustafa Muhammad were Jorge "The Truth" Teron and Joel "El Rey" Castillo, JAB members. They thanked the two locals for their loyal support since JAB was started in 2003. Mustafa Muhammad had a 16-year career as a professional boxer. He posted a 50-8-1 record with 39 knockouts and was the WBA Light Heavyweight champ in the early 1980s.

Get A Withdrawal Card When You Leave Your Job

Be sure to request a withdrawal card within 90 days from when you are laid off, called to active duty, terminated, retire, go on disability or leave the craft. The charge for the withdrawal card is \$0.50. All initiation fees and back dues must be up to date before the withdrawal card is issued. Mail or bring in the form below to the Local 295 office along with your check or money order for \$0.50. It is your responsibility to obtain a withdrawal card. Failure to obtain a withdrawal card might obligate you to pay extra dues and re-initiation fees.
