Being in the 'Green Zone" means the plan is considered healthy under federal guidelines with sufficient assets to meet its obligations to participants and retirees.

This milestone marks a major achievement representing years of commitment and collaboration from the Union and Company Trustees. Years of consistent contributions, sound management and adherence to the Plan's Rehabilitation Plan adopted in 2009 restored the Fund's financial strength. Strong investment performance and careful oversight by the Trustees have helped it reach its' stable and healthy status. In the coming months, the Plan's actuaries, Union and Company Trustees will review potential plan design improvements with the goal of enhancing benefits where feasible.

I regret to report that the current global and national economy has resulted in low volume of shipping in the airfreight industry, and along with the negative impact of automation in operations has led to companies downsizing and some of our shops are suffering layoffs.




After more than **50 years of dedicated service at the Funds Office**, Linda Kellner has worn many hats and excelled in every role she embraced.

Get a Withdrawal Card When You Leave Your Job

Do not forget to file for a Withdrawal Card within 90 days from when you are Laid Off, called to Military Duty, Terminated, Resign, Retire, go on Disability or leave the craft. The charge for the withdrawal card is \$0.50. All initiation fees and dues must be up to date before the withdrawal card is issued. It is your responsibility to obtain a withdrawal card.
Failure to obtain a withdrawal card might obligate you to pay extra dues and re-initiation fees.
